

Activity summary 2015-16

The Victorian Refugee Health Network ('the Network') is auspiced by the Victorian Foundation for Survivors of Torture Inc (Foundation House). The Network aims to facilitate greater coordination and collaboration amongst health and community services to provide more accessible and appropriate health services for people of refugee backgrounds in Victoria.

Major projects and key activities

Community Consultation: Talking about health and experiences of using health services with people from refugee backgrounds

In 2015-6 the Network conducted a major project to consult with people from refugee backgrounds, including people seeking asylum, about their experiences of using health services in Victoria.

The project drew on the expertise of bicultural workers employed in Victorian health, community, and settlement agencies, and resourced these workers to conduct consultations with the refugee background communities in which they work. 115 consultations were conducted with individuals and groups from refugee backgrounds across Victoria. The project collated themes identified in the responses and, under eight key themes areas, collated the perspectives of community members, findings that were particularly strong for specific sub-populations of the consultation respondents, perspectives of advisory group members, case studies of good practice approaches to supporting people's wellbeing, and recommendations for a range of stakeholders.

Primary Care Project

The Network built on the work commenced in 2014 on the Primary Care project, which aimed to increase the number of general practices who are able, willing and confident to work with people from refugee backgrounds. 2015-16 Project activities included the development of a series of tools and resources, including a Framework for Continuing Improvement, outlining systems and skills required to deliver healthcare to people from refugee backgrounds in the areas of communication, coordination and management, and clinical care. Primary Health Care Forum – August 2015

The Primary Care Forum on 27 August 2015 brought together 60 primary health care practitioners with an interest in the delivery of responsive, accessible and appropriate primary health care to people from refugee backgrounds and asylum seekers. Participants included GPs and Refugee Health Nurses, specialist services, policy makers and researchers from both metropolitan and regional Victoria to discuss a range of topics on refugee related health care. Presentations included community perspectives, immunisation, optometry, the NDIS, health literacy, and the Victorian refugee and asylum seeker health action plan. Afternoon workshops included mental health, chronic health, and barriers and enablers in the provision of primary care. Immunisation

The Immunisation Working Group brought together key stakeholders to improve access to catch-up immunisations for people from refugee backgrounds including people seeking asylum in Victoria. In 2016, the working group prepared briefing papers on: No Jab, No Pay – implications for service providers and refugee background communities; and ACIR – Issues Arising and presented them to relevant government bodies. The group developed resources including an information sheet for GPs and other immunisation providers; and an information sheet for caseworkers and other health service staff. A catch-up immunisation workshop for refugee health nurses was organised and delivered at the Refugee Health Program Networking Day at Foundation House in May 2016. The Working Group contributed to the development of a multilingual brochure on catch-up vaccination for clients produced by the Centre for Culture Ethnicity and Health.

Stakeholder engagement, communication and dissemination

This past financial year the website has been used as a tool to collaborate with partners on large projects and disseminate project resources and information rapidly, for instance in the Primary Care. 74 new pages and posts were created in 2015-16, primarily in our library to showcase reports and resources related to refugee health, but also including the development of content related pages

e-Bulletin

Subscription to the e-Bulletin continues to increase, with subscription base 1470 people at the end of June 2015, covering a broad range of subscribers from organisations including primary and secondary health, government, community services, education and settlement services.

Policy and Practice Update

Network Policy and Practice Updates are a quarterly, state-wide, invite-only web-conference. The updates are designed to facilitate rapid, two-way information sharing, where participants can receive policy and program updates, hear short presentations from others working in refugee health, and have opportunities to make contributions. Invited participants include representatives from the Department of Health & Human Services (DHHS), Primary Health Networks, specialist refugee health services, community health, GPs, refugee health nurses and allied health workers employed by the Refugee Health Program, and asylum seeker and settlement support services. The Network hosted four online policy and practice updates, with participation from across the state.
